Topical Talk Festival Parental Permission Form

About the Topical Talk Festival

Your child's school is participating in a project called the Topical Talk Festival. It is delivered by The Economist Educational Foundation, a charity that was set up from inside *The Economist* newspaper.

The project will take place over several weeks. It will give children valuable knowledge about the news, the skills to explore different points of view and make up their own minds, and the confidence to have their say.

They will have weekly discussions about the news at school with their teacher, where they will be presented with factually-accurate information and balanced arguments. They will also have opportunities to take part in safe online discussions about the news with young people living in different parts of the world, and experts on the topics. They might take part in live events, such as webinars.

Topical Talk Student Hub

As part of participating in the Festival, children's work and comments expressing their views on the news may be published on a public online website called the Topical Talk Student Hub (the "Hub"): https://talk.economistfoundation.org/. Children's work might be in writing, audio or video formats.

When a child's work or comments are published on the Hub, the name and personal details of the child are NOT published. Every child is given a made-up name which is randomly generated by the system (with an adjective and a noun, such as "strong_sheep"). This made-up name will be notified to your child by their teacher. No one at The Economist, The Economist Educational Foundation or any public visitor to the Topical Talk website will know the child's real name or their personal details other than the name of their school, which is published together with their made-up name.

All work posted by students on the Student Hub is subject to a moderation process. Work submitted in audio or written format will be moderated by The Economist Educational Foundation to ensure that is safe an appropriate for children. Work submitted in video format will additionally need to be approved by the student's teacher, who is responsible for their photo and video permissions, before being moderated by The Economist Educational Foundation.

The Economist Educational Foundation might share children's work or comments (and their made-up name) that are published on the website elsewhere online, or in print, on television, on radio or other channels to support or promote its charitable work. The Economist Educational Foundation will never publish the name or personal details of the child.
